Call to Order

Kenneth moved to approve the September 22nd minutes. Kate seconded. All board members present favored.

School year Board of Directors meeting calendar amended to include a Thursday night meeting on December 17th. November 17th will be the next Board Meeting. Bev moved to approve, Kate seconds. All present favored.

Financial Update: presented by Jacob Welp and Kathy Benzel

• Lori and Kathy connected on final revisions

- Lots of budget changes based on middle school expansion costlier model but worth it
- October count: 660 student count
- Analyzing Fun Club financial projections trying to figure out where our #s will fall plan to meet with Mariam to review her business plan
- Revenues are trending as expected K tuition is coming in higher
- Salary & benefits below the baseline they've increased with budget changes running a bit high due to Calvary
- District expenses remain the same
- FY16 Approved budget and working budget
 - approved budget = \$5.9M expenses & \$5.9M revenue
 - working budget = \$5.9M expenses \$5.7M revenue
- Transportation fees should we include student fees?
- Why do we have a \$200K shortfall? Staffing Asst. Principal is included but should the Dir. of Development be included? Kathy thinks that position's salary is supposed to come from reserves

Marketing – we need to start thinking about advertising for Jan/Feb? Kristy will help with advertising – working with Megan

Principal Update: Kathy Benzel

- Kathy is very excited about the level of instruction she is seeing
- 4 Kindergarten classes are all strong
- Janine visited and was very impressed with the routines already established
- Kathy will attend a 2-day coaching program Amy & Teresa will attend as well
- Better Immersion has been a great addition for K-2 Mandarin focus to take that program to the next level
- Mimi Met, national world language specialist, is coming in January
- Need to get a trainer for the Chinese teachers to take it to the next level

- Raised \$40k with direct giving party so far about to send out an email campaign to bring in more
- 80 families that have not yet donated but did last year could be a matter of timing
- Next fundraiser spring kickball tournament
- Other events: restaurant nights, holiday gift drive, etc.

Calvary Temple Update:

- Moving forward all communication goes from Anne to Rod
- Soccer Field making a decision to put in artificial turf
- Elevator additional design needs to happen can't happen during school 2 month project - will need to happen in summer
- Air Conditioning will be installed over winter & spring breaks

Long Term Facilities Update- presented by Kristy Fantz

- Sent our proposal in September
- DPS will come out with a new application process similar to Facility Allocation process
- Our chances are less favorable because we would have to accept students at every grade and we can't due to our model so it will be tough for us to get an existing DPS facility
- Still think we have a good shot for the Bond
- December next cycle for facility allocation for Middle School and we would have a very good shot – for Fall 2017 – most likely NE Denver and for a High Quality Middle School
